## CERTIFICATE OF RESULTS 2017 EXECUTIVE BOARD ELECTIONS

I HEREBY CERTIFY THE FOLLOWING AS THE TRUE AND ACCURATE RESULTS OF THE EXECUTIVE BOARD ELECTIONS HELD BETWEEN NOVEMBER 20, 2017 THROUGH DECEMBER 11, 2017:

### OFFICE OF THE PRESIDENT VOTE RESULTS

Members Not Voting:	1,499 (64.53%)
Ballots Disqualified:	298* (36.16%)

### RESULTS (Votes Received)

Votes Cast for William Young:	477 (57.89%)
Votes Cast for Ryan Huizinga*:	298 (36.16%)
Votes Cast for Roger Doyle:	49 (5.95%)

\*It has been determined by the Trial Committee that Ryan Huizinga was guilty of certain charges pursuant to RSA Bylaws. The RSA Board of Directors voted to affirm those findings on appeal and concluded that he is not a member in good standing and not eligible to be a candidate for the position of President effective December 6, 2017 and his name should be immediately removed from the ballot. Any vote cast for him prior to that time shall not be counted. On December 7, 2017 at 1400 hrs, the RSA Election Committee, via RSA Staff, requested Ryan Huizinga be removed from the ballot. The votes cast for Ryan Huizinga were subsequently preserved but disqualified.


Uncontested Candidates
