"I have been refused the right to have a representative of my choice. I understand that I am being ordered to make a report or answer questions and that, if I do not comply with the order, I may be disciplined for insubordination.

Therefore, I have no alternative but to abide by the order. However, by so doing, I do not waive my constitutional rights to remain silent under the 5th and 14th amendments to the United States Constitution and under the protections afforded me under state law."

The purpose of this event was to provide an opportunity for the retired members to possess and maintain their “CCW” and “HR-218” qualified credentials - which allows them to lawfully and legally carry firearms within the state of California - as well as nation-wide [as governed by the HR-218 standards].

The event was well attended, and the actual range qualification procedure was concise, efficient, and a quick process for those who participated (most attendees completed the process within 15 to 20 minutes of their arrival). The RSA Rollin’ Smokehouse & Chow Shack was on hand to provide breakfast for retirees and BCTC staff. This event was enhanced by the knowledge, hospitality, and professionalism of the BCTC CCW and range staff.

If you are interested in establishing or maintaining your HR-218 CCW permit status, we look forward to facilitating your certification at the next retiree qualification course. The next retiree qualification course has been tentatively scheduled for March 22, 2023, at the Ben Clark Training Center. I will provide specific details in the near future where RSVP protocol is concerned.





# The 2022 Legislative Scorecard



A look back at a year's worth of public safety votes

The end-of-session scramble saw the legislature dispense with nearly 1,000 bills during the final weeks of August. It is always difficult to condense an entire year's worth of public safety votes into a single article and scorecard. Many of the most significant bills from this year are omitted because they failed to pass through both houses of the legislature. Some failed passage out of committee or were defeated on the floor before they could advance to the opposite house. Still others advanced but were later killed in the Appropriations committee or the author pulled the bill due to lack of votes needed for adoption.

RSA's legislative efforts, in conjunction with the other major law enforcement associations, were successful in defeating or significantly amending many of the more egregious senate and assembly bills earlier this year. Bills to eviscerate the Peace Officers' Bill of Rights, permanently ban the use of facial recognition technology with body cam footage, and prevent law enforcement organizations from financially supporting district attorney candidates were among those killed earlier this year. Since those bills did not survive to receive a floor vote in

both the Assembly and Senate, they are not included in this scorecard.

Also excluded from our scorecard are numerous RSA-supported bills that passed on unanimous or near unanimous votes. We've historically omitted such bills from our scorecard due to their non-controversial status and list some of them below.

- AB 2274 statute of limitations extended to hold mandated reporters accountable for failure to report
- SB 284 PTSD workers' comp presumption for dispatchers
- SB 367 mandates naloxone to be available on all college campuses
- SB 850 death benefits for children of peace officers / firefighters
- SB 916 sexual assault victims' rights
- SB 1034 sexually violent predators; court placement oversight
- SB 1081 expanded revenge-porn definitions
- SB 1087 catalytic converter theft prevention
- SB 1472 vehicular manslaughter; speeding/reckless driving



**RSA-OPPOSED  
CONTROVERSIAL BILLS

- SB 300 no LWOP/death penalty required for cop killers, other first-degree murderers w/special circumstances
- SB 325 places criminal defense attorney on CalGang oversight panel
- SB 519 decriminalizes hallucinogenics including LSD, ecstasy, mescaline/peyote, magic mushrooms, etc
- SB 710 prevents law enforcement groups from contributing to DA campaigns
- SB 1000 restrict law enforcement use of encrypted radio communications
- SB 1021 pre-trial diversion for DUI; no record
- SB 1039 permanent ban on facial recognition technology used with body cams
- SB 1088 effective elimination of certain peace officer rights

- SB 1173 CalPERS divestment from fossil fuels industry
- SB 1273 remove mandated reporting of drugs, violence in schools
- SB 1464 mandates peace officers enforce public health orders (churches, masking, social distancing, etc)

A casual reader might conclude that the defeat of these RSA-opposed bills demonstrates a willingness on the part of the legislature to side with law enforcement over the “progressive” interests of the ACLU and other hard-left advocacy groups. Such a reader would be incorrect. California remains a staunchly Democratic and liberal-leaning state.

For more proof, one needs to look no further than the dozens of pro-law enforcement and pro-public safety bills that the RSA and other peace officer groups supported, yet which failed to advance during the 2021-2022 legislative year. Many address the current criminal sentencing policies enacted over the last decade by the voters or the legislature. A half-dozen measures addressed the insignificant penalties associated with retail theft and sought to overturn parts of Propositions 47 & 57 which appear to have significantly contributed to the revolving door of criminal acts, citation and no meaningful deterrent. Other bills sought to increase criminal penalties for catalytic

converter thefts, but they too were defeated. Another handful of bills invoiced the fentanyl epidemic and efforts to hold accountable those that sell fentanyl-laced drugs to unsuspecting buyers. All were defeated.

Furthermore, for 20 years, the public safety committees of the senate and assembly have adopted a policy of blocking bills that would create new felonies or increase the criminal penalties for existing ones. For the last decade, these policies have also been routinely applied to misdemeanor bills.

Legislators are keenly aware of these policies, although some continue to introduce bills to correct what they see as inadequate or non-existent criminal penalties for certain offenses that have been in the news lately such as the catalytic converters, retail theft and fentanyl. Sometimes media coverage can amp the pressure on the legislature to address such issues, but usually not.

Criminals are spending less time behind bars. Violent crime is on the rise. Lawmakers are hearing complaints from their voters. The criminal justice “pendulum” in our state has swung back and forth over the decades. Only time will tell if the current criminal trends will motivate voters and the public at large to send a message to their elected representatives.

# Don't Let Turnouts Turn Into Cancer For You And/Or Your Family

**T**he subject of polyfluoroalkyl substances — also known as PFAS — was reviewed and discussed by the International Association of Fire Fighters (IAFF) and the Metro Chiefs, and a joint statement was issued on August 23, 2022 under the heading “IAFF AND METRO CHIEFS ADVISE MEMBERS OF ADVERSE HEALTH RISKS LINKED TO FIRE FIGHTER TURNOUT GEAR”. According to that statement:

“Recent studies have shown all three layers of the protective clothing contain Per and Poly-fluoroalkyl Substances (PFAS) chemicals, which have been linked to cancer — the leading cause of fire fighter deaths.”

As a result of these studies:

“The IAFF and Metro Chiefs are encouraging members to reduce their exposure to PFAS by limiting use of turnout gear only to emergency responses where its protection is a necessity. Wearing all PPE and self-contained breathing apparatuses during firefighting, overhaul, and working in smoke remains the best first line of

defense to protect from fireground contaminants until PFAS-free alternatives are available.”

Jamie DeWitt, a toxicology professor at East Carolina University, has commented on the subject of PFAS exposure:

“We actually know very little about how PFAS penetrates through the skin . . .”

“Firefighters may be at particular risk of exposure to PFAS from clothing because they wear their gear for long periods of time, often while they’re sweating and exposed to high heat.”

“When you’re sweating, your pores open up, your capillaries dilate. So it’s easier to absorb things that might be in materials that are on your skin.”

These comments clearly reflect the substantial health risk created by PFAS exposure contained in the clothing turnouts that firefighters wear while doing their job — sometimes for long periods of time.

Several articles address the exposure firefighters have to PFAS while wearing their turnouts, and the increased risk of developing cancer as a result of such exposure. The next step is to recognize that the failure of protection from PFAS exposure carries over to the families of firefighters.

In Law1199.com Newsletter 2022 Issue #5, I addressed the protection needed by those who have lead exposure and the protection needed for their families. That protection is needed now, not later, and the same is true for those who have PFAS expo-

sure. Again, *we're talking not only about those who have direct PFAS exposure, but their families as well.*

Firefighters should be provided time at work to undergo a complete cleansing from head to toe to remove any residue of harmful exposures they have throughout their career. The goal is to remove any cancer-causing particulates so the firefighters themselves are free of these dangerous substances and are not cancer carriers to their families at home.

A protocol needs to be established so firefighters can have their clothing properly cleaned after each PFAS exposure so it is ready for use again the next time it is needed. This cleansing will protect the firefighters themselves, their families, and anyone else with whom they come into contact.

It does not take much observation to recognize that if, after a shift, a firefighter is not given the time needed for proper cleansing of the gear which has been worn — as well as time to

clean themselves — they may go home carrying harmful substances which may be spread to family members. In addition, those contaminants may spread to any place the firefighter goes, such as

when traveling in their car. It does not take much evaluation to realize that driving in the car day after day — after wearing the firefighting gear each day — will only increase the level of pollution and its potential impact on both the firefighters and their families.

*Again, protection is needed not only for firefighters, but for their families and friends as well.* The cleaning must be thorough and complete --- including the uniforms, the turnouts and the breathing apparatus — before the next shift comes on. *THIS IS A NECESSITY.* The health risks posed by uniforms, turnouts and breathing apparatus flows over to health risks for the families involved.

At this time, a protocol must be established to protect workers (and their families) following the end of each shift. Ample time must be allowed so workers can clean themselves thoroughly and not carry any contaminants home to their families or the public. ★




