RSA Legal Defense Alert!!

Always consult with an association representative/lawyer before responding to any report, letter, memo and/or questions concerning an investigation that could possibly lead to punitive action. If ordered to do so, ask to have it recorded and read the following: Non-waiver statement:

"I have been refused the right to have a representative of my choice. I understand that I am being ordered to make a report or answer questions and that, if I do not comply with the order, I may be disciplined for insubordination. Therefore, I have no alternative but to abide by the order. However, by so doing, I do not waive my constitutional rights to remain silent under the 5th and 14th amendments to the United States Constitution and under the protections afforded me under state law."




Lieutenant Nathan Kaas



Legal Defense For Armed Correctional Deputies II

Several months ago, I wrote “Legal Defense for Armed Correctional Deputies” in response to some inquiries into the coverage that RSA’s Legal Defense Trust would extend to ACDs. Since then, we have received a legal opinion from one of our labor attorneys, Elizabeth Silver, indicating that ACDs do not require a CCW because their 830.1(c) status, issued by the Sheriff, affords them legal authorization to carry a firearm off-duty.

Since my analysis partly relied on the erroneous assumption that ACDs lacked authorization to carry a firearm off duty without a valid CCW, I thought it necessary to revisit the article. Before doing so, I discussed this with the LDT Board of Trustees to ensure the article accurately represents their views on this issue. After all, they are the ones who review and vote on applications for coverage, so their opinions are far more relevant than my own.

For clarity’s sake, rather than write a second article, I thought it best to simply include the first article in its entirety with “track changes” to note any changes resulting from the legal opinion. Substantive changes to the original article are highlighted. Ms. Silver’s legal opinion is available via QR code.

LEGAL DEFENSE FOR ARMED CORRECTIONAL DEPUTIES

As more Correctional Deputies transition to Armed Correctional Deputies (ACDs), RSA felt it would be beneficial to provide some information regarding the Legal Defense Trust’s (LDT) coverage limitations and recommendations for additional coverage. This article will provide you with language from LDT’s Plan Document (which can be found on RSA’s website, www.rcdsa.org), specific scenarios with coverage analysis for each scenario, and contact information for CCW “insurance” companies (although most of us refer to these plans as CCW insurance, they are really pre-paid legal plans).

While reading the scenarios and analysis, please remember three things. First, our members can and should apply to LDT for coverage if they are involved in a shooting, even if it seems unlikely that an incident would be covered. Second, the final decision on whether or not to provide coverage is made by the LDT Trustees, with

input from General Counsel and Trust Counsel. If coverage is denied, our members can apply for coverage with RSA’s Legal Review Committee (LRC). In such cases, RSA’s Executive Board hears the appeal and renders a decision. If the LRC denies coverage, members can make one final appeal to the Legal Coverage Appeals Board (LCAB), which is comprised of members from RSA’s Board of Directors. The third thing to remember is that the decisions made by these boards are usually factspecific. A change to just one part of the scenarios described below may result in a different coverage decision.

As you know, LDT provides administrative (PERS) coverage for all cases through a Skelly Hearing, as well as criminal coverage for all cases arising out of the course and scope of one’s duties. What this means for ACDs is that LDT would likely provide criminal coverage for a shooting that occurred on duty but would not likely provide criminal coverage for an off-duty shooting (because ACDs are not 24/7 peace officers). because enforcement actions are generally (but not always) outside the course and scope of their duties. However, there are scenarios that could change these generalizations. For example, an on-duty shooting that was so far out of policy that it would be considered outside course and scope, or an off-duty shooting that was somehow related to work and thus could be considered within course and scope. In the following scenarios, it is assumed that the ACD has a valid CCW it is assumed that an ACD’s 830.1(c) status gives them legal authorization to carry a firearm both on and off duty.

Please note that the following scenarios are hypothetical and merely serve as useful illustrations. I am not an attorney; nothing in this article should be construed as legal advice.

SCENARIO #1

Inmate Miller is about to begin his homicide trial. Knowing that a conviction is virtually assured, he talks his brother into helping him escape from custody. Inmate Miller tells his brother to be at the hospital the next night. His plan is to fake chest pain so that the medical staff will send him to the hospital. His brother will find him at the hospital, disable the ACD who is guarding him, and they will both flee to Mexico.

The next night, Miller is transported to the hospital, and ACD Jones is assigned to accompany him. While at the hospital, Miller's brother attacks Jones with a knife. Jones shoots Miller's brother twice in the chest, and the escape attempt fails.

The Force Investigations Detail (FID) conducts a criminal investigation to determine whether Jones' actions were lawful, and Miller's family files a civil lawsuit against Riverside County, naming Jones as a defendant.

ANALYSIS:

Jones discharged his weapon while on duty. His actions were clearly within the course and scope of his employment. FID would determine that Jones was acting in defense of his life, and the District Attorney would conclude that the shooting was lawful. RSO would probably not conduct a PERS unless the FID investigation indicated there were policy violations that should be addressed (such as failure to activate the BWC). LDT would send a labor rep and an attorney on the day of the incident and would continue to provide representation throughout the FID investigation (as well as a PERS investigation if necessary).

The County would defend against the civil lawsuit and indemnify ACD Jones.

SCENARIO #2

ACD Jones is off-duty and attending the premiere of *Fast & Furious 40* with his girlfriend. After the movie, as they walk through the parking lot, they see someone trying to burglarize their vehicle. Jones places the suspect at gunpoint and tells him to "freeze." The suspect ignores the command and charges at Jones with a large screwdriver raised over his head. Believing he was about to be stabbed with the screwdriver, Jones shoots the suspect twice in the chest. Since the incident occurred in the City of San Bernardino, SBPD conducts a criminal investigation, RSO conducts a PERS investigation to determine if any Department policies had been violated, and the suspect's family files a civil lawsuit against Jones.

ANALYSIS:

SBPD would determine that Jones was acting in defense of his life, and the District Attorney would conclude that the shooting was lawful. However, Jones discharged his weapon while off duty. Unlike Deputy Sheriffs, ACDs do not have peace officer powers while off duty have training and experience enforcing the law so Jones' actions would likely not be considered within the course and scope of his duties. Therefore, LDT would probably not provide legal defense for the criminal investigation. To determine whether LDT would provide criminal coverage, Trustees would have to weigh the fact that Jones was acting in defense of his life against the fact that his initial action, proactive law enforcement, was outside the normal course and scope of his duties as a correctional deputy. While discussing this with the LDT Trustees, they specifically requested that I

discourage ACDs from off-duty enforcement actions.

Since LDT provides coverage for all PERS investigations through Skelly, Jones would be provided an LDT attorney for the PERS interview. If any discipline were imposed, the same attorney would represent him during the Skelly hearing. Since representation beyond the Skelly is not guaranteed for actions taken outside the course and scope of employment, Jones would have to apply to LDT for further coverage if he elects to appeal the discipline in an arbitration hearing. Additionally, Jones would be exposed financially as a result of the civil lawsuit because neither LDT nor RSA would pay any judgment or settlement stemming from the lawsuit. Since County Counsel's legal opinion differs from ours (they do not believe an ACD's 830.1(c) status affords them the right to carry off duty), the County would not likely indemnify Jones, and his personal assets may be exposed to civil litigation.

SCENARIO #3

ACD Jones is working in the front lobby of the jail. He looks outside and sees his girlfriend's brother "Ron" approaching the public entrance to the jail lobby. Ron looks angry and demands to speak with Jones outside. Jones goes outside with Ron, who angrily demands payment for their fantasy football league. Ron tells Jones that the season ended a month ago, and he still has not paid. He threatens to post a screenshot of the final standings on social media, showing that Jones finished in last place and did not even win a single game. Terrified that all of his friends and co-workers will find out how bad he is at fantasy football, Jones panics and shoots Ron twice in the chest. FID conducts a criminal investigation, RSO conducts a PERS investigation, and the family files a civil lawsuit against Jones.



ANALYSIS:

Obviously, Jones violated state law and department policy. Even though the shooting took place while he was on duty, the incident would be considered outside course and scope. LDT would only provide coverage for the PERS through Skelly and would not provide any criminal or civil representation. Jones would be solely responsible for any judgment or settlement resulting from the civil lawsuit.

SCENARIO #4

ACD Jones is off duty but at the courthouse to marry his girlfriend (despite his issues with Ron). After parking his car, he is approached by two male subjects he recognizes from the jail. One of them shouts, "Hey Dep! Remember that time you refused to give me a sack lunch?!" The other subject removes a gun from his waistband and points it directly at Jones, who quickly draws his firearm and shoots the subject twice in the chest. FID conducts a criminal investigation, and RSO conducts a PERS investigation. The family files a civil lawsuit against Jones.

ANALYSIS:

Although Jones was off duty, he could make a compelling argument that the incident should be considered within the course and scope of his duties because the two suspects would not have engaged him if they had not recognized him from work. He was not taking enforcement action; he was simply defending himself against a threat that would not have arisen were it not for his employment.

Ultimately, the LDT trustees must decide whether the incident should be considered within course and scope. There is at least a reasonable likelihood that the trustees would agree with Jones. If so, LDT would represent him criminally and administratively through an arbitration hearing if necessary. However, LDT would not be responsible

for paying any judgment or settlement resulting from the civil lawsuit, so Jones' assets may still be exposed.

In conclusion, the hypothetical situations illustrate some crucial generalizations. Most importantly, LDT's plan document provides for criminal coverage only if a member's actions are within the course and scope of employment. Since deputy sheriffs are peace officers both on and off duty, they may be called upon to take enforcement at any time. As 24/7 peace officers, an off-duty shooting would generally be within the course and scope of their employment. However, when an ACD goes off-duty, they become a private citizen with a CCW. Therefore, an off-duty shooting would not generally be within the course and scope of their duties. As 24/7 peace officers, trained and experienced in crime prevention and the apprehension of suspected criminals, an off-duty shooting would generally be within the course and scope of their employment. However, an ACD typically does not receive the same training, and their typical duties do not include crime prevention or the apprehension of suspects. Therefore, an off-duty shooting would not generally be within the course and scope of their duties. Even if it were, neither RSA

nor LDT would help pay any civil judgments or settlement costs. For these reasons, RSA recommends CCW insurance to ensure adequate legal representation and to protect your financial assets following an off-duty shooting.

As you may be aware, LDT provides optional CCW insurance for retirees at a very low cost. However, the plan only provides the bare minimum of coverage and does not protect against civil judgments. Since, at present, it is only for retirees, RSA recommends purchasing it so you can access LDT attorneys for your case. RSA strongly urges our members to purchase additional CCW insurance, such as CCW Safe (855- 639-2297 or ccwsafe.com), Right To Bear (protectwithbear.com), or USSCA (877-677-1919 or uscca.com).

There are other plans, but whichever plan you select, be sure to choose one that protects your financial assets against both legal fees and civil judgments or settlements.

AB 1293 Needs Labor Participation

The California Constitution has set forth that the worker in California who sustains a job-related injury may have entitlement to special benefits. The most significant benefit is the medical care to cure or relieve the effects of the injury as stated in the California Constitution Article 14 Section 4.

The access to this medical care is also set forth in the Labor Code and can be dependent upon a physician's report that grants, denies or limits the medical care.

For the California worker there is implementation of changes and access to medical care that occur pursuant to Senate Bill 899. This legislation was effective as of April 19, 2004, and since that time there have been numerous concerns and challenges as to the usage of this system of Senate Bill 899.

The current system can utilize a Qualified Medical Evaluator (QME) to make medical determination as to the need for the medical care and whether it will cure or relieve the effects of the



injury. The QME's are doctors that are randomly selected by the state from the panel list that they have. A panel of three doctors will be provided based upon the medical specialty and proximity to the worker's residence. The QME's are selected by either the injured workers participation or the injured workers attorney, and/or the employer and their selection process.

The QME doctor reviews medical records, evaluates the injured worker, and then within thirty days of this evaluation they are to provide a report to the injured worker, and the parties, whether that be the injured worker's attorney, and/or the defendant. This could be an insurance company, city, county, state or self insured. The worker and the other parties can dispute the findings of the QME's report. There is a process they must go through to challenge the determination as to the adequacy, or lack thereof.

The workers' compensation system can also create major challenges to obtain medical care. The workers' compensation system has challenges with the medical providers to understand the system and respond in a timely manner with depth and knowledge to justify the acceptance, denial or limitations on medical care.

The California Legislation has placed the direction and control of the workers' compensation system on the Administrator Director of the Division of Workers' Compensation. The Administrator Director of the Division of Workers' Compensation has established, and is currently establishing, rules and regulations that do not go through the legislative vetting process. These rules and regulations are directed as to what care is granted or what care is denied, and the methodology of determination for same.

On October 3, 2025, Governor Newsom approved Assembly Bill 1293. This mandates that the Administrator Director of the Division of Workers' Compensation will develop a template for the QME's report (i.e., the template to be utilized by the QME). This legislation of having a format for the QME's is such that if the reports do not meet the parameters set forth by the Administrator Director of the Division of Workers' Compensation, it may be subject to challenge and overturn any determination made by the QME. Again, it is noted that the QME is not the treater, but a doctor who has examined the medical reports and examine the patient and the patient's perspective as to their subjective complaints.

The Template that will be mandated pursuant to Labor Code §4062.4 is one that needs to be closely reviewed. It should be noted that Assembly Bill 1293 has been reviewed by the legislative counsel. The review of AB 1293 SHOWS SUPPORTERS, it does not list any opposition. The supporters are entities such as Acclamation Insurance Management Services, Allied Managed Care, California Association Self Insured groups, California Joint Powers Authorities, California Attraction and Park Association, California Chamber of Commerce, California Collation of Workers' Compensation, California Joint Powers Insurance Authority, Food Producers, California Restaurant Association, California State Association Counties, Rural County Representatives of California, Rural County Representatives of California Self Insured Schools, and Creator of Coachella Valley in Urban Counties of California.

This is a strong indicator that the employer groups are recognizing that Administrator Director of the Division of Workers' Compensation participation will be a strong factor in the control of medical care to lower costs.

The labor groups must view and monitor the California workers' compensation medical care access, and

participate and provide information to the Administrator Director of the Division of Workers' Compensation to ensure that any and all changes that are made relative to the determination of medical care and other factors that may evolve such as time lost from work, the ability to return to work, inability to return to work, and need for medical care to cure or relieve the effects of the injury are equitable and not slanted to deny or limit medical care. It is important that the Administrator Director of the Division of Workers' Compensation is comporting with the law that if the injured worker has a job related injury, that they are entitled to medical care to cure or relieve the effects of the injury and balance this finding with the containment and control that employers, insurance companies and self insurers seek to impose to minimize the cost of medical care. Therefore, labor committees, labor associations and unions must present information to the Administrator Director of the Division of Workers' Compensation as to the need for medical care to cure or relieve the effects of the injuries and ensure that the systems utilized are fair, equitable and protect the injured worker. ★

The bills selected for the 2025 scorecard were voted on by both houses of the legislature. Each bill faced significant opposition. One bill failed final passage, two were vetoed and the rest were signed into law by Governor Newsom.

Overall, 2025 was a pretty good year for public safety and law enforcement interests. Even the six major opposition bills listed in the scorecard were all significantly watered down and amended. While we are grateful for the narrowing amendments, we remained opposed to them all because they still infringed on officers' ability to effectively perform their duties.

Chef's Corner



Green Bean Casserole



Cook Time: 45 Minutes



Prep: 10 Minutes



Serves: 6 - 8

Ingredients:

- 1Lb Fresh Green Beans
- 3 Tbsp, Unsalted Butter
- 8 Oz Cremini Mushrooms, can substitute White Mushrooms
- ½ Tsp Salt
- ¼ Tsp Pepper
- 3 Minced Garlic Cloves
- 2 Tbsp Flour
- 1 Cup Broth, Vegetable or Chicken
- 1 Cup Heavy Cream
- 2 Cups Fried Onions
- ¼ Cup Panko Bread Crumbs
- ¼ Cup Finely Grated Parmesan Cheese

Instructions:

- Step 1: Prep the oven and pan: Preheat oven to 375°F and grease a 9x13-inch dish.
- Step 2: Blanch the green beans: Boil green beans in salted water for 3–4 min, then cool in ice water. Drain and pat dry.
- Step 3: Make sauce: Melt 2 Tbsp butter in a skillet. Add mushrooms, salt, and pepper; cook 5 min. Stir in garlic for 2 more min. Mix in flour, then broth; simmer 2–3 min. Add cream and cook until thick (5–10 min).
 - Shortcut: Use canned cream of mushroom soup or sauce instead.
- Step 4: Combine: Add green beans and 1 cup fried onions to sauce. Stir and transfer to the dish.
- Step 5: Toast topping: Melt remaining 1 Tbsp butter in a skillet. Toast panko for 3–4 min; season lightly.
- Step 6: Bake: Top with remaining onions, toasted panko, and Parmesan. Bake 20 min, uncovered, until bubbly.
- Step 7: Serve and enjoy!
