- If you marry or enter a domestic partnership, contact the Benefits Office at (951) 653-8014 within 30 days of marriage or entering the partnership.
- If you divorce or terminate a domestic partnership, contact the Benefits Office at (951) 653-8014 within 30 days of divorce or termination.
- If you become a legal guardian, adopt a child, or become legally separated, contact the Benefits Office at (951) 653-8014 within 30 days of the event.
- To ensure coverage, please respect these deadlines. Remember that the department does not notify the Benefit Trust of these changes.
- Please notify the Benefits Office of any changes in your address.
- Please provide dependent substantiation documents to the Benefits Office when requested to avoid cancellation of your dependent's coverage.

RSA Legal Defense Alert!!

Always consult with an association representative/lawyer before responding to any report, letter, memo and/or questions concerning an investigation that could possibly lead to punitive action. If ordered to do so, ask to have it recorded and read the following: Non-waiver statement:

"I have been refused the right to have a representative of my choice. I understand that I am being ordered to make a report or answer questions and that, if I do not comply with the order, I may be disciplined for insubordination.

Therefore, I have no alternative but to abide by the order. However, by so doing, I do not waive my constitutional rights to remain silent under the 5th and 14th amendments to the United States Constitution and under the protections afforded me under state law."

Qualified professional use includes work equipment, uniforms, supplies, firearms, ammunition, K-9 accessories, First Responder/Law Enforcement approved education course (up to 1 year) and certification training courses such as POST required courses. NOTE: For educational and certification training use, funds must be disbursed directly to the training institution, or reimbursement to member if valid receipt provided showing payment made within preceding 60-days.

Public Safety Unit Update

PSU Survey Coming Soon

A little over a year ago I wrote that RSA planned to survey the Public Safety Unit (PSU) staff to determine if we wanted to join the Association as full members. That survey should be ready soon. The PSU bargaining team is deciding whether to keep it simple or include a series of questions.



I suspect we will ask a single question to keep the process simple. To better prepare you for the vote, I am listing a few of the pros and cons here; and refer you to the APB article from August 2023 for more information. You can also reach out to a local site rep, bargaining team member, or email / call me to discuss any concerns you might have.

The most obvious pro is a true partnership with the RSA including voting rights. Right now my position is honorary and we (members) cannot vote for any elected board personnel, bylaws, etc. nor can we serve on the Executive Board of the Association. We also have no access to their benefits trust (insurance). Note, the benefits trust has not had a rate increase in over twelve years, while our costs have gone up nearly every year. Additionally, while the assault on law

enforcement has diminished some, there is still a movement to abolish the police and turn probation services over to community based organizations. We and RSA need to fight that locally, in the state capitol, and nationally. That fight costs money and RSA needs our financial support.

The most obvious con, really the only con, is the increased cost of membership. Right now we pay half the dues so that means full membership will cost twice as much. I realize times are hard with lingering inflation, rising insurance costs, increasing costs of goods and services, etc., however, we can't just think short term. That short sightedness is what the county does; we need to plan and prepare for the future.

Under RSA's guidance, we have seen improvements and this is simply the next step in obtaining more. We must unite behind RSA and pay our fair share. In the future, if we are able to enter RSA's benefits trust, many staff will see cost savings, assuming they select reasonable medical coverage, not a Cadillac plan. That savings should more than cover the increase in dues. Some staff may be money ahead.

When the survey is released, please vote to join RSA as full members. Don't get hung up on the short term cost, instead, look at it as a long term strategy to strengthen the Association and eventually gain more benefits. A no vote can be likened to stepping over dollars to pick up pennies.

Chef's Corner

Tomato Bisque



Cook Time: 60 Minutes



Prep: 10 Minutes



Serves: 6-8



Ingredients:

- 6 Red Tomatoes
- 6-8 Heirloom Tomatoes (colors can vary)
- 1 Bulb of Garlic
- 1 Whole Yellow Onion
- 1/4 Cup of Heavy Cream
- 2 Cups Chicken Stock
- Fresh Basil Bushel
- Olive Oil
- 2 Tbsp Balsamic Vinegar
- 1 Tsp Sea Salt
- 1 Tsp Pepper
- 1/2 Tsp Paprika
- 1/2 Tsp Garlic Salt

Instructions:

- Step 1: Preheat oven to 400 degrees.
- Step 2: Slice the tomatoes and onion into fourths and scatter onto a baking sheet lined with parchment paper. Be sure to leave room in between do not layer them.
- Step 3: Cut the end off the bulb of garlic and place in the center of the tray, still in the peel.
- Step 4: Chop one bushel of basil and scatter around the tray, along with the sea salt, pepper, paprika and garlic salt.
- Step 5: Drizzle olive oil and balsamic vinegar over the top. And place in the oven for 35-40 minutes, or until the onions have browned slightly.
- Step 6: Remove baking sheet from oven and allow to cool slightly before placing the contents into a blender. Making sure to squeeze the now roasted garlic out of the peel.
- Step 7: Once blended thoroughly, add the contents to a large pot with the chicken stock, bringing it to a slight boil. Stirring often.
- Step 8: Add the Heavy whipping cream and another basil bushel (whole) and allow to simmer for 10-20 minutes.
- Step 9: Remove the basil bushel and season to taste.
- Step 10: Serve alongside your favorite grilled cheese or garlic bread and enjoy!





Armed Correctional Deputy Training 830.1 P.C. Transition Course

The Armed Correctional Deputy Training Transition Course is continuously conducted at the Ben Clark Training Center. The most recent course took place October 1-15, 2024. The two-week 830.1(c) Penal Code certified course is designed specifically for correctional deputies who travel armed during the course and scope of their employment. This role carries a significant amount of responsibility. There are a number of legal issues to consider.

Penal Code 835a(a) provides legislative intent with respect to an officer's decision and tactics during a use of force, when it involves the use of deadly force. The course provides a foundation for students, encouraging them to be mindful of the totality of the circumstance when faced with a potentially deadly force situation.

Additional legislation seeks to guide the administrative and criminal investigative procedures following an officer involved shooting. Many of these legal issues are addressed and discussed during the course. To ensure that these legal issues are properly addressed, members of the Riverside County Sheriff's Department Force Investigation Detail provided training regarding Department policy and the legal protocol for the criminal investigation process.

As a retired Riverside County Sheriff's Department - Central Homicide Unit / Force Investigations Detail, and Professional Standards Bureau investigator, I believe it is important to participate with the 830.1 course along with RSA



Legal Defense Trust Attorney Robert Todd (Stone Busailah). Together, we provided course attendees with a comprehensive understanding of the immediate legal guidance and support they will receive during the investigation following an officer involved shooting, or critical incident.

Lastly, it is also important to consider and prepare for what comes after a deadly encounter. There are several liability coverage programs that help its members prepare for the "before, during, and after of a self-defense incident." Retiree Director Frank Anderson is your point of reference should you have any questions about supplemental liability coverage.



HERE THERE BE MONSTERS: For your Halloween pleasure, a monster-sighting account from 1958 that was investigated by our very own Riverside County Sheriff's Department. The incident involved a number of sightings, including an "attack" against a motorist, sheriff's deputies investigating, and the help of a pair of boys. The "Monster of North Main Street" turned out to be a hoax, although the prankster may have continued to get away with it were it not for those meddling kids... and some monster-hunting deputies.

**Monster Said
Monstrous Hoax** 11-12-58

Tracks in the sand, Halloween-type rubber claws, and a car seat cover apparently added up to a gigantic hoax by Riverside's big-haired monster saga.

Tracks discovered by a pair of youngsters in the Santa Ana River bed matched a pair of rubber costume claws that were found by a police officer at a Riverside service station early yesterday morning.

A pair of boys said they found the tracks from a new beast with the rubber claws of Halloween toys, John Crooks and Dennis Wiley, said.

AND THESE, said a sheriff's deputy (Monday) seeing a figure last night, seem to fit the description of the "monster" in the pattern of a "woodchuck down prank."

Still to be found are the ghostly face mask and the person who was wearing it, deputies said.

Sheriff's Capt. Robert Pinsky said and Fred Hanson, Press-Photo had said the department Enterprise photographer, to the left, said he observed the tracks.

"We would like to discuss the matter with him," Pinsky said. He did not elaborate, but earlier warned that if it was a prankster, the "spook" risked getting shot.

The monster was first reported by Charles Wetzel of Bloomington. Last Saturday night Wetzel reported to the Sheriff's department that as he was driving along North Main street he encountered "a two-legged" beast where the street dips and crosses the river, about a half-mile north of the city limits.

A WEIRD looking thing rose up out of the thick fog at that time and it made a lunge at him across the hood of his car, leaving wavy clawlike marks on his windshield, he said.

Wetzel was thoroughly frightened by the incident, but when he arrived at home, he decided to notify the Sheriff's office next business day. He did not elaborate, but they checked the area, dated and appeared to be a hoax.

Social Media and Workers' Comp: Oversharing

Social media serves to connect friends and family over a variety of platforms (Instagram, Facebook, Tik Tok, etc.); however, that same connection is often shared with co-workers and peers. At what point is a person's social media presence a detriment should that person find themselves in any legal situation? How does a seemingly "friendly" request or simple post create so many problems?



be taken completely out of context and misconstrued, it does not change the fact that legitimate questions can be asked about them.

THIS DOESN'T APPLY TO ME BECAUSE MY SOCIAL MEDIA IS SET TO "PRIVATE"?

While restricting access to your content is an excellent start, it will not save the day. The intent of restricting access to other "non-friends" does not overcome the very nature of social media; it is a public forum. "Friends" within your network have access to your posts and what they see, or share with others, could ultimately end up as the target of legal discovery.

THE LAW AND SOCIAL MEDIA

Social media has evolved into a primary source of discoverable information in virtually every legal proceeding. How has this occurred? The answer is simple, in the information-gathering phase of litigation called "discovery," *the law allows for the discovery of all relevant (or potentially relevant) information*. Considering social media posts are created by the individual (or someone authorized to act on their behalf,) it is in completely fair legal territory to obtain all details surrounding the who, what, when, where and how of an individual's posts or the posts of others.

WHAT INFORMATION OR CONTENT CAN BE OBTAINED/ASKED ABOUT?

With the understanding that almost everything is "discoverable," I frequently field simple requests for an individual's social media account username all the way to utilizing specific pictures/posts in a line of questioning. From a workers' comp perspective, the obvious questions surround an individual's physical abilities or their current activities (outside of the workplace too.) If an individual is fresh from surgery, unable to work because of a doctor's note or even placed on light-duty because of a doctor's note, sharing photos of physical activities (i.e. hiking, motorcycle riding, relaxing at the river, etc.) can easily be construed by a department, or others within your network, as possibly exceeding those limitations. While it is unfair that posts/comments can

HOW CAN I PROTECT MY SOCIAL MEDIA ACCOUNTS?

Restricting access like a "private" setting helps, but the core of protecting yourself in these scenarios' rests with the actual content of a post/story/reel etc. Ask yourself a few basic questions before posting: Why am I posting this? Who can see this post? Can this post/interaction be misinterpreted? Granted, asking yourself all of these questions over every simple post (or interaction) is nearly impossible, but it could save you from a legal headache down the road.

THIS MEANS I NEED TO DELETE ALL MY SOCIAL MEDIA, RIGHT?

Before jumping off the cliff and scrubbing your social media presence, it is important to take a step back and look at what you are *actually* sharing. There are countless scenarios in which social media can be used as an extremely positive tool. Connecting with friends (even co-workers) is positive if done with an understanding that you could one-day be asked about it. Relaxing with family or enjoying an evening doesn't have to be kept private; rather, just be cautious of what (and who) is being posted.

Labor Code §3212.15 has an expiration date of 01/01/2029. This legislation has been drafted and implemented in the awareness there is a segment of the labor market that has a higher exposure to horrendous and demanding events that occur during their employment.

The awareness is situations that can evolve from long term exposures at work or specific horrific events of work. The diagnostic term that is used is Post-Traumatic Stress Disorder (PTSD) that is characterized by the Diagnostic Statistical Manual of Mental Disorder and is published by the American Psychiatric Association.

The individual who develops or manifests this problem may indeed have need for medical care to cure or relieve the effects of the problem. There is awareness that certain occupations have a higher propensity for these horrific events such as firefighters and police officers.

Once it has been established that the PTSD is work-related, this allows medical care with providers that are doctors that in all MUST have a better understanding as to the demands of firefighters and police officers. This understanding affords a higher level of care and enhances the likelihood of curing and relieving the effects of the injury.

CHALLENGES TO CARE

Several challenges for many of the individuals that suffer from PTSD is the recognition of what is going on and the connection with a medical provider that has in-depth knowledge of what the worker has done in their career, and how many times there has been a long stage of denial in seeking care because culturally for some groups it is not perceived to be strong for the worker to seek out care. By receiving care from a provider that understands this perspective, the worker has a better opportunity to improve.

IMPACT ON LIFE AT HOME

The improvement that is needed is not just for the work situation, but overflows into their domestic life. As the worker changes because of horrific events they have endured, and continue to have in their work situation, there is a continuation of the thought process not just at work, but also impact on their domestic situation.

This overflow from the work can have a negative impact on the family. Therefore, the worker has two points that they have to deal with. One is the work situation that is creating exposure to stressful events i.e., shootings, high speed pur-



suits, fires where someone is burning/burnt, death of young children, or suicides. These events are contributory; however these events are also situations that do happen and at the end of the workday they carry over whether that is week, a month or year upon year, into their domestic life.

The second point is a change of the family environment; growing apart from the family and members breaking down due to what has occurred and is occurring at work.

Again the emphasis of being treated by a doctor or a group of doctors that have awareness substantially increases the likelihood of recovery and being able to return to work. Also equally important is trying to make the domestic situations non-volatile and more pleasant for all.

URGENCY OF CARE

Labor Code §3212.15 establishes a presumption that lessens the burden of proof, but still requires a burden of proof to articulate the stress. Labor Code §3212.15 has an expiration as of 01/01/2029.

It is a necessity to ensure that the members are getting the medical care to cure or relieve the effects of the PTSD. It is also very important for the Associations and Unions to communicate with the Assembly Members and State Senators as to the ongoing challenges that exist and the improvement that is derived from the proper medical care to cure or relieve the effects of the injury. There is also a segment that allows for the worker to seek out benefits following the termination of employment for a period of up to sixty months depending on the length of time that the worker has been employed in that area, and lifetime medical on the job-related condition.

PTSD STUDY

Labor Code §3212.15 sets forth a study that is to be completed by the Commission on Health and Safety and Workers' Compensation. This study will reflect information on PTSD and what benefits were paid. This study should also look at not just what the cost of benefits have been, this study should also look at the success of the workers and their family have had with the proper medical care to cure or relieve. The report focused in the past as to what compensation

was paid. This study needs to go beyond the compensation paid and look at the access to medical care to cure or relieve the effects of the injury and make sure that there is enough opportunity for the proper and correct doctors to provide this care to cure or relieve.

This study is to be completed and shall be provided to the Senate Committee on Labor and Public Employment, Retirement, Assembly, and the Committee on Insurance no later than 01/01/2025. Once this study has been done the various Unions and Associations that represent the worker should be aware of it, but they also should be aware of what parameters of the study are to make sure it is not just what the costs are to the employer, but the improvement to the worker and to the worker's family to cure or relieve the effects of the injury.

RELIEVING THE EFFECTS OF INJURY

Workers' compensation is for the employee who sustained job-related injury. Labor Code §3212.15 recognizes a section of coverage under the presumption, but Labor Code §3212.15 requires additional expansion for other public employees that have also horrendous, demanding and stressful jobs such as public safety telecommunications, emergency response communication employees, and dispatchers. These individuals also on a continuum on a day to day basis have exposures to horrific events. These people are at risk due to these exposures.

The primary purpose of workers' compensation is not to infuse money into the worker, but to cure or relieve the effects of the injury and allow the injured worker to function at a higher level so they can continue with employment and continue to have a positive relationship with the domestic partner/families.

There may be some compensation paid as permanent residual impairment, but that amount that is paid is small in light of the long lasting effect of PTSD. Again, awareness as to this study by the Commission on Health and Safety In Workers' Compensation Study Due Date of 01/01/2029 on PTSD that is going to be offered and at the same time the need to educate the legislators, whether that is the Assembly or the Senate as to the need to protect those that protect us. ★
