RSA Legal Defense Alert!!

Always consult with an association representative/lawyer before responding to any report, letter, memo and/or questions concerning an investigation that could possibly lead to punitive action. If ordered to do so, ask to have it recorded and read the following: Non-waiver statement:

"I have been refused the right to have a representative of my choice. I understand that I am being ordered to make a report or answer questions and that, if I do not comply with the order, I may be disciplined for insubordination.

Therefore, I have no alternative but to abide by the order. However, by so doing, I do not waive my constitutional rights to remain silent under the 5th and 14th amendments to the United States Constitution and under the protections afforded me under state law."

Polpettone



"Big Meatball"



Cook Time: 45 Min



Prep: 20 Minutes



Serves: 6-10

Ingredients:

- 1 1/2 lb of Ground Beef
- 2 Whole eggs
- 1 Finely Chopped Onion
- 4 Cloves of Crushed/Minced Garlic
- 1/4 Cup of Grated Parmesan
- 1/2 Bread Crumbs
- Salt & Black Pepper to taste
- Italian Seasoning
- 2 6 oz cans of Tomato Paste
- 2 Cups Mozzarella Cheese
- Fresh Basil

Instructions:

- In a large bowl add the ground beef, eggs, bread crumbs, parmesan cheese and. Mix until all ingredients are well combined.
- Finely chop your onion and add to the mixtures, along with the seasonings. (Salt, Pepper, and Italian Seasoning)
- Once fully combined, spread mixture onto a flat surface and flatten into a 1/2 inch rectangle.
- Add the minced garlic to the tomato paste and combine.
- Spread 3/4 of the mixture evenly on the 1/2 inch rectangle.
- Add the layer of mozzarella cheese and fresh basil, and roll the meat into a loaf.
- Place in a well greased loaf pan and cover with the remaining tomato paste and mozzarella cheese.
- Cover with foil and bake for 40 mins at 350 degrees. Remove foil for the last 5 minutes of bake time. Slice and enjoy!

Hallucinogens And Unintended Consequences

Over the last half-decade, repeated efforts have been made by state lawmakers to legalize various hallucinogenic drugs. They've tried to legalize, for recreational and other purposes, LSD, GHB, Magic Mushrooms, Ketamine, Peyote, Mescaline, Ayahuasca and Ecstasy. All of these bills either failed or were eventually vetoed. Surprisingly, it is not the Democrats alone who have been supporting these bills. A handful of Republicans have also co-authored and voted in favor of the misguided legislation.

Senator Scott Wiener (D-San Francisco) has taken the lead on most of these efforts, alternatively arguing that these drugs might be able to help persons suffering from PTSD. However, the language written into his bills would have completely decriminalized and established the lawful recreational use of hallucinogenic drugs.

The efforts were again defeated with this year's bill that was drafted to establish a "psychedelic facilitation" oversight bureaucracy in state government, similar to the CA Department of Cannabis Control. After that bill failed, a new bill was introduced in early June which takes a more limited approach. SB 803 is jointly authored by Democrat state Senator Josh Becker (Bay Area) and Senate

Republican Leader Brian Jones (San Diego), and allows veterans and former first responders to use psychedelic mushrooms in conjunction with facilitation sessions.

Despite inconclusive research results and a refusal by the US Food & Drug

Administration (FDA) to approve usage of psychedelic mushrooms for therapeutic (or any other) purposes, legislators seem intent on establishing some lawful form of hallucinogenic use in our state.

As part of our mission to advocate in opposition of bills that risk the safety of the public, we've outlined our concerns surrounding this latest proposal below. Among other things, the bill does the following:

- Allows growing, transporting, selling, possessing and using psilocybin, psilocyn (and any other psychedelic substances authorized by law)
- Allows persons who claim to be veterans or first responders to use psilocybin
- Must be over 21 and pass a suitability screening
- Any type of medical doctor can oversee its use, no expertise required
- Permits mushroom use in San Diego, San Francisco and Santa Cruz counties
- No PTSD, treatment-resistant depression or any mental health diagnosis required
- No requirement that the person taking mushrooms stay at the facility while intoxicated
- Prohibits lawsuits and administrative penalties against psychedelic operators unless gross negligence or bad faith is proven
- Mushroom users will be barred from lawfully purchasing firearms

MAGIC MUSHROOMS

According to the Drug Enforcement Agency, the active ingredient in “magic mushrooms” is psilocybin, a Schedule I substance under the Controlled Substances Act, meaning that it *has a high potential for abuse, no currently accepted medical use in treatment in the United States, and a lack of accepted safety for use under medical supervision.*

The psychological consequences of psilocybin use include hallucinations and an inability to discern fantasy from reality. Panic reactions and a psychotic-like episode also may occur, particularly if a user ingests a high dose. The physical effects include nausea, vomiting, muscle weakness, and lack of coordination. Effects of overdose include longer, more

intense “trip” episodes, psychosis, and possible death. <https://www.dea.gov/sites/default/files/2020-06/Psilocybin-2020.pdf>

While some studies seem to indicate there may be the potential for positive outcomes associated with mushrooms and some mental health issues, other studies have shown no significant difference when compared to a routinely prescribed selective serotonin reuptake inhibitor (SSRI). Some research shows that that patients do not experience any strong positive effects from psilocybin use.

More study and clinical trials are clearly needed in this area before making it widely available in three of California’s counties.

FIREARMS PURCHASES & MUSHROOMS

Would persons (veterans and former peace officers especially) be

barred from purchasing firearms under federal law which prohibits the use of illegal drugs (including Schedule 1 substances)? Hunter Biden, the son of President Joe Biden, was recently convicted for failing to disclose illegal drug use on federal firearms purchase form. The form, ATF Form 4473, includes standard questions about things that would disqualify someone from legal gun ownership, like previous felony convictions, mental health problems or illegal drug use. ATF Form 4473 prohibits use of any drug which is illegal under federal law - including cannabis and mushrooms. As a result, it appears that the use of mushrooms would preclude veterans and peace officers using mushrooms pursuant to SB 803 from lawfully purchasing firearms.

VETERAN / FORMER FIRST RESPONDER STATUS

The bill permits hallucinogenic drug consumption by veterans or former first responders. Former first responders are defined in the bill. Veterans are not.

- There are no provisions in the bill for the facilitator or the county public health department to verify a person’s claim to be a veteran or a former first responder.
- As a result, anyone could claim to be a veteran to inappropriately access hallucinogenic mushrooms.
- Would/should veterans from another country qualify?
- Would/should a veteran who was dishonorably discharged for violence or other serious misconduct qualify for this mushroom-based “therapy?”

ACTIVE DUTY EXCLUDED, BUT RESERVES & NATIONAL GUARD PERMITTED

SB 803 allows “veterans” to take these drugs and specifically excludes anyone on active duty in the military.

However, no similar prohibition applies to persons serving in the Reserves or the National Guard. As such, veterans in the Armed Forces Reserves or the California National Guard who are currently serving are *not* excluded from taking these intoxicating drugs.

DISCIPLINE / LIABILITY

Will persons who consume mushrooms be subject to discipline if their employer learns that they have used these substances?

- This bill provides sweeping liability protections to mushroom facilitating centers that far exceed the

protections granted to traditional medical treatment facilities. Hallucinogenic mushroom facilitators will face no civil or administrative liability unless “gross negligence or acting in bad faith” is determined.

- Claims made pursuant to violations of health, employment, safety, and environmental laws, for example, would be required to meet this incredibly high standard of proving gross negligence or bad faith before and remedies would be possible.
- The same heightened standard would apply to medical malpractice allegations at these facilities, even though the bar to sue doctors at cancer treatment and other facilities is significantly lower.

NO MENTAL HEALTH DISORDER DIAGNOSIS REQUIRED

SB 803 justifies permitting legal use of magic mushrooms to help treat veterans and first responders with serious mental health disorders. In support of this goal, the bill asserts there is preliminary clinical evidence indicating psilocybin may demonstrate substantial improvement over available therapies for treatment-resistant depression.

- FDA has *not*, however, approved psilocybin for treating such mental health disorders and that clinical trials remain ongoing.
- SB 803 requires no diagnosis of any mental health disorder of the veterans or first responders seeking these hallucinogens, despite its

claims about trying to help those suffering from PTSD or “treatment-resistant” depression, but doesn’t require “patients to have a professional diagnosis of PTSD or treatment-resistant depression or *any* mental health disorder.

- SB 803 makes mushrooms available to anyone claiming to be a veteran or former first responder over the age of 21 who passes a “suitability screening” which does not require any mental health disorder diagnosis.
- To remain constant with the bill’s stated claims and purposes, SB 803 should not permit persons without a medical diagnosis of PTSD or treatment-resistant depression to participate in this dangerous experiment.

INEXPERIENCED FACILITATORS PERMITTED

SB 803 allows licensed physicians and surgeons to dispense mushrooms without any requirement that these doctors be specialists in the field of mental health or psychiatry.

- Should a dermatologist, urologist or gynecologist dispense mushrooms and oversee these mushroom-fueled mental health treatment sessions?
- Should a cardio-vascular surgeon or orthopedic surgeon oversee hallucinogenic treatments?

EFFICACY OF PSILOCYBIN/PSILOCYN

The language of the bill acknowledges that the science around mushrooms and mental health is inconclusive, asserting that, “*Emerging*

Making a false or fraudulent workers’ compensation claim is a felony subject to up to five years in prison or a fine up to \$50,000 or double the value of the fraud, whichever is greater, or both imprisonment and fine

research suggests that psilocybin and psilocyn, when used in a controlled and facilitated setting, may offer significant benefits in treating mental health disorders, particularly those related to trauma and stress.

“Suggest” and “may” are not scientific terms upon which hallucinogenic drugs should be dispensed and the medical community remains divided on the benefits and risks associated with these hallucinogenic drugs.

As pointed out earlier, the FDA has not approved mushrooms for use in any type of treatment and significant, ongoing research and study continues.

ENSURING SAFETY

The bill also contends that, “The facilitated use of psilocybin and psilocyn should be available to veterans

and former first responders in a manner that ensures safety...”

- Unfortunately, SB 803 in no way ensures that “safety” for the those seeking mushrooms or the safety of the public will not be compromised.
- Nothing in the bill addresses the potential harm to persons using the mushrooms, including flashbacks, or the threat to public safety caused by a person experiencing the high or a wflashback.

INGEST MUSHROOMS, THEN LEAVE?

Nothing in SB 803 empowers the “facilitator” or anyone else to prevent the person who just consumed mushrooms from leaving once intoxicated.

- If a person takes the mushrooms and then decides to leave while high, what result?
- The facilitator cannot detain the intoxicated person against their

will. The person while high on mushrooms could simply walk or drive away.

TESTING CONCERNS

Earlier this month, the FDA issued a warning about magic mushroom micro-dosing chocolate bars, infused cones and macro and micro dose gummies. “People who became ill after consuming these products “reported a variety of symptoms including seizures, central nervous system depression (loss of consciousness, confusion sleepiness) agitation, abnormal heart rates hyper/hypotension, nausea and vomiting. <https://www.fda.gov/food/outbreaks-foodborne-illness/investigation-illnesses-diamond-shruumzbrand-chocolate-bars-cones-gummies-june-2024>

While such contamination is probably not the norm in this emerg-

ing industry, it does raise concerns about the existing testing and purity standards that these companies claim to maintain. This remains a serious concern.

FLASHBACKS

Although not as common as many believe, Hallucinogen Persisting Perception Disorder (HPPD) occur when people experience the same images or scenes they saw when they were under the influence of a substance. Flashbacks can be brief or can reoccur for years after an experience with a substance. They can occur at anytime - while driving, at work or while caring for family members. There is nothing in this bill that addresses the possibility of flashbacks. <https://nida.nih.gov/research-topics/psilocybin-magic-mushrooms#is-psilocybin-safe>

ALASKA AIRLINES PILOT MENTAL BREAK

Late last year, an off-duty Alaska Airlines pilot who was accused of trying to bring down an Alaska Airlines flight told investigators that he took psychedelic mushrooms 48 hours before the incident, that he had been depressed and that he believed he was experiencing a mental breakdown.

He has been charged in state court with 83 counts of second-degree attempted murder and one count of endangering an aircraft; a separate federal case includes one count of interfering with a flight crew or flight attendants... the FBI is investigating whether he was under the influence when he tried to shut down the plane's engines while he was sitting in the cockpit on a flight to San Francisco. <https://www.nbcnews.com/news/us-news/-duty-alaska-airlines-pilot-accused-trying-shut-engines-wrestled-cockpit-rcna121906>

CONCLUSION

The potential harms to which these dedicated public servants will be subjected, as well as to the public at large, far outweigh any inconclusive benefits that some individuals might possibly gain. Our veterans and first responders should not be used as guinea pigs in the effort to legalize dangerous hallucinogenic drugs. By not requiring the "facilitators" to be medical doctors who are trained experts in mental health or psychiatrists who specialize in providing treatment with these powerful drugs to oversee this "pilot program," SB 803 will unnecessarily put the public our veterans and first responders - **with no diagnosis of PTSD or treatment-resistant depression** - at risk.

This is why so many law enforcement organizations throughout the state oppose these dangerous bills.

We'll keep you updated as this bill and the others advance during the remainder of this legislative session.

Until next month, be safe. ★

FACILITATION CENTERS NOT LIMITED TO MUSHROOMS

Despite claiming the bill is limited to only psilocybin/psilocyn, SB 803 includes an exception that would also permit these "facilitation" centers to dispense additional hallucinogenic drug, which could include ecstasy, ayahuasca, mescaline, and even LSD pursuant to local ordinances.

In the bill, Section 2 §11302(b) states, "A psychedelic-assisted facilitation center shall not possess or administer any other psychedelic substance, *unless otherwise authorized by law.*"

There is no need to insert this language in the bill, unless some local governments plan on declaring via a local ordinance that these other dangerous psychedelics are to be "authorized by (local) law."

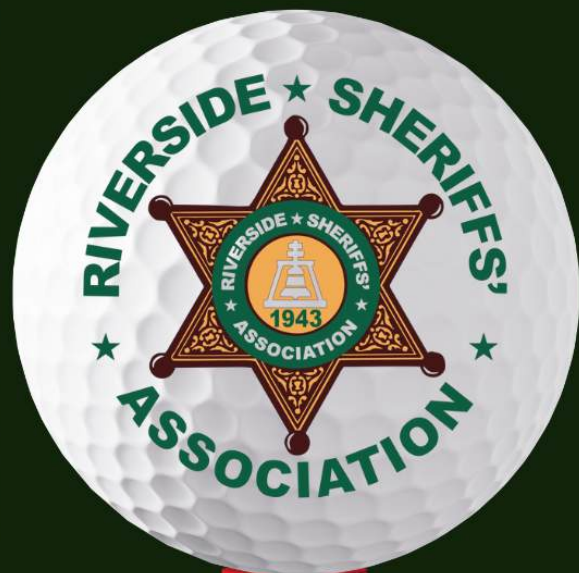

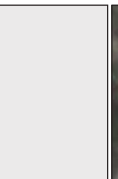
