"I have been refused the right to have a representative of my choice. I understand that I am being ordered to make a report or answer questions and that, if I do not comply with the order, I may be disciplined for insubordination. Therefore, I have no alternative but to abide by the order. However, by so doing, I do not waive my constitutional rights to remain silent under the 5th and 14th amendments to the United States Constitution and under the protections afforded me under state law."

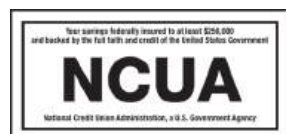

Chef's Corner

MOJO CHICKEN



Cook Time: 30 Minutes



Prep: 30 Minutes

*not including marinade time



Serves: 6-8



Ingredients:

- 6 garlic cloves, peeled
- 1 medium shallot, rough chopped
- 1 teaspoon kosher salt
- 1 zested lime
- 1 ½ teaspoons ground cumin
- 1 teaspoon dried oregano
- ½ teaspoon ground pepper
- ½ cup orange juice
- ⅓ cup of lime juice
- ⅓ cup extra virgin olive oil
- 3 lbs. boneless, skinless chicken thighs

Instructions:

- Step 1: Combine the marinade ingredients and blend until smooth. Hold 1/3 of the marinade to the side for a final garnish and dipping sauce.
- Step 2: Add the marinade and chicken to a large Ziplock bag. Get as much air out as possible. Marinate for up to one day.
- Step 3: Preheat grill on medium-high heat and lightly oil the grates. Place the chicken on the grill and let it sear for approximately one minute. Then decrease the heat and cook for 15-20 minutes. Ensure the internal temperature reaches 165-degrees.
- Step 4: Reduce the reserved sauce over medium-high heat until it thickens and drizzle over the chicken. Enjoy.

Buffington Represents At World Police & Fire Games

Senior Probation Officer Tyler Buffington once again showed his skills during the 2025 World Police and Fire Games.

Held in early July in Birmingham, Alabama, Buffington said the event drew more than 8,500 athletes from 60 countries.

This was Buffington's second trip to the World Police and Fire Games, having previously competed in 2017 when the games were hosted in Los Angeles.

Buffington competed in the cornhole and billiards events, earning a gold medal in the singles cornhole portion where he beat an NYPD officer in the finals.

In the cornhole doubles competition, he partnered with a firefighter from St. Louis. Together they earned a bronze medal.

"My partner was honoring a close friend and fallen firefighter that passed away last year from cancer," Buffington said. "They used to compete together in

the cornhole event, so it was special we were able to earn a medal in his honor."

Buffington went on to earn another bronze in straight pool, narrowly edged out by competitors from Ireland and Singapore. "The competition was intense, and it truly tested me."

"I take great pride in being able to compete and earn these medals while representing my department, Riverside Sheriff's Association, and country," he said. "It was truly special and an awesome experience."

Tyler said that, according to the official medal count, this makes Riverside County Probation one of only four probation departments to medal at the games (Riverside, Los Angeles, San Francisco, and Sacramento). ★

Election Update - Assembly District 63 (Riverside County)

Since none of the four candidates received over 50% of the vote last month, the top two vote getters will face each other in a run-off election to be held August 26.

Republican Natasha Johnson amassed 46% of the votes cast - about 1,000 more votes than the 42% her opponent, Democrat Chris Shoults. Voter turnout was a paltry 18% for the special primary election which had been called to fill the vacancy created by the resignation of former Assembly member and current interim U.S. Attorney Bill Essayli.

"As an Assembly member, I will support law enforcement to keep our neighborhoods safe, fight Sacramento taxes and red tape to lower our cost of living and protect parental rights and put students and parents first." - Natasha Johnson (R)

"My top priority will be to deliver resources and commonsense solutions. We need to lower the cost of living, make housing affordable, create good paying jobs ... and protect our freedoms and our safety." - Chris Shoults (D)

Assembly District 63 is a relatively safe Republican seat with GOP voters holding a 6% registration advantage. While 6% registration may not seem insurmountable for a democrat, it resulted in a 57% - 43% victory for Essayli's re-elect in 2024.



Since none of the four candidates received over 50% of the vote last month, the top two vote getters will face each other in a run-off election to be held August 26.



Ballots for the AD 63 special election will arrive in mailboxes during the last week of July. The RSA, along with other law enforcement groups, have endorsed Johnson.

LEGISLATIVE UPDATE

The legislature began its month-long summer break and will return Monday August 18 to complete the final month of its regular session.

We continue to track and actively advocate on more than 90 remaining bills that will impact officers or public safety.

KNOW WHAT IS IN YOUR FILE: Court Orders Full Disclosure of Brady Materials in Personnel Records

Schneider v. Superior Court of Los Angeles County

Overview: A recent California appellate decision has clarified how courts must handle *Brady* material found in peace officers' personnel records—and the ruling has major implications for how your file may be disclosed in a criminal case.

The Case: Robert Schneider was charged with murder and sought discovery under *Pitchess* and *Brady*, asking the court to review confidential personnel records of six Los Angeles County Sheriffs (LASD) deputies. After an in-camera review, the trial court agreed that four deputies' files contained *Brady* material but only ordered disclosure of the names, addresses, and phone numbers of people who had witnessed or complained about the conduct, rather than the *Brady* material itself (i.e. not the actual documents, reports, or recordings).

Schneider challenged the limited disclosure—and the appellate court agreed with him.

The Ruling: In *Schneider v. Superior Court of Los Angeles County*, (Cal.Ct.App.2025) the appellate court found that when a court finds *Brady* material in a peace officer's personnel file, it must disclose all of it, not just witness contact information. Disclosure includes written documents, internal reports, audio or video recordings and any material favorable to the defense and material to guilt or punishment.

The Court made two key points: When a trial court conducts a judicial review of an officer's personnel file for *Brady* discovery, it is essentially executing the prosecution's *Brady* duty and must disclose any *Brady* material it uncovers.

1. Which means, *Brady* disclosure is not limited by *Pitchess*. While *Pitchess* provides the procedural gateway to access confidential personnel records, it does not limit the scope of *Brady*-required disclosures once that gate is opened.
2. The court acts on behalf of the prosecution. When conducting an in-camera review, the judge is fulfilling the State's constitutional obligation to turn over exculpatory evidence. That means full *Brady* compliance is required.

What this Means for Officers: Once your file is subject to an in-camera *Pitchess* review, any material deemed favorable to the defense must be turned over- without redaction or limitation.

This ruling underscores the importance of maintaining integrity and professionalism in every encounter, as they may result in discovery.



The Department should ensure legal teams are coordinated with prosecutors on potential *Brady* disclosures.

Key Takeaway: If it's in your file and it's *Brady*—it's getting disclosed. This decision reinforces the need for all officers to understand how personnel records intersect with Constitutional discovery obligations.

Heat Exposure/ Heat Damage

Heat exposure can be a very damaging element of the safety officers' assignments. There are numerous work placements that the safety officers are in that create heat-related injuries such as fire scenes, controlling traffic and accident scenes on hot days. Over a period of time these assignments, depending upon the level of heat temperature, can be a very significant factor in the manifestation and/or development of symptoms that are reflective of potential heat damage. Some of the exposures can have impact on your mental state; some of the exposures can have impact on your physical state. Being in the hot environment can impact many of your abilities. At higher levels of temperature for a longer period of time these exposures can alter the mental state and go as far to cause seizures depending upon the body temperature and your ability to hydrate.

Common sense is providing the safety officers the proper opportunity to hydrate and be in shaded or cool areas. The reality is that the common sense approach is not available in many assignments that they are in; such as emergency situations. The officer's awareness of heat-related nausea, dizziness, sweating and other factors need to be documented with their medical providers. This documentation can be a shell of protection.

There is another segment of the labor market that has heat exposures, and there is currently special legislation being proposed in the workers' compensation arena for agricultural workers regarding the pronounced

heat exposures they have. Senate Bill 1336 is legislation that examines and acknowledges the heat-related exposures these agricultural workers have. This legislation would create a presumption that if these agricultural workers have said heat exposures they would be entitled to receive medical care and other ancillary factors because of the uniqueness of their exposures. This would be a presumption.

The acknowledgment of the heat exposures and impact upon this group of workers is accounting for their unique assignments. It must also create an awareness that another segment of our work force, the safety officers, have extreme heat-related exposures protecting our society. We as citizens need to make sure that these safety workers, indeed, can benefit from the medical care to cure and relieve the effects of these exposures. The burden of proof for



these heat-related exposures and damages must fall within the presumption that is akin to heart, hernia, and cancer.

The safety workers unique mandate is that they must be on the scene to protect the citizens of California and do not many times have the options of avoidance of heat.

The impact can be extreme causing cardiovascular problems, dizziness and heating spell. This heating spell is called syncope. A protocol should be available to allow the safety officers to hydrate and be in shaded spots, many times this cannot occur because of the extended period of time required to protect. For the safety officers that are having continued symptoms, after or during the event, such as muscle cramps or spasms, it is important that they be aware that this could be an indication of heat exhaustion and they should seek medical care. Another factor is that they can develop a heat

rash and this could be a situation that is long-lasting in the duties that they are performing.

The documentation of the first symptoms and any residual symptoms especially post the assignment is imperative. This documentation should be through a doctor or a medical facility. This again is significant if there is a continuation or symptoms post these exposures. If there is a continuation of symptoms a worker must file a claim form with the employer reflecting the assignments and the manifestation and development of the symptoms with the particular assignment.

There are times after the exposure to the heat there is a tolerance in the mind of the worker that they have the ability to return back to work and are not impacted, but yet they are impacted. Documentation is important. The workers' compensation system provides care to cure and relieve the ef-

fects of the injury, and the care to cure and relieve the effects of the injury may be short term if in fact there is a promising recovery. If there continues to be changes such as heat rashes and or other symptoms, this could be an indicated of a potential higher level of damage such as a stroke. Documentation is important. As indicated earlier, the workers' compensation system is acknowledging that agricultural workers in certain areas have a higher propensity for damages from the heat-related illnesses. This awareness should be also be transferred to the awareness that safety officers have with their particular assignments at times requirements to be exposed to high heat exposures. The exposures to the high heat again can be fire scenes, controlling traffic, and other situations on hot days. The impact is physical and the impact can be emotional. Documentation is paramount for protection. ★

Exposure To Harm And The Knowledge Of Same Can Be Your Protection

As the heat level increases, along with the change in Air Quality Index (AQI), there is an expansion of exposures that all California workers will have due to the level of heat and the wildfires that develop and become problematic to contain and control. Fires are a strong developmental component of particulates that adversely impact the AQI. The AQI measurement reflects the level of air quality in relation to wild land fires, structure fires and vehicular exhaust.

There are many occupations/careers that protect us from wild land fires, structure fires, vehicular fires (such as trucks/auto) and rioting that occurs also causing harm by fires.

The University of California, Davis has reviewed the measurements of the AQI. The University has raised the concern that the AQI for agricultural workers increases the level of pollutants that they are exposed to. This study does not dive itself into the exposures that safety officers have at fires; whether that be wild land, structure fires, vehicle fires, or trying to redirect, contain and/or control traffic, but does state the higher level of risk to air pollution.

The safety officers protecting our society for many hours or several days while having these exposures can strike their pulmonary system by breathing damaged air. If they are out there for lengthy periods of time they will dehydrate, and that water used to replenish their system can have exposures to these particulates that cause problems either now, or later. An additional factor is that as these safety workers stand protecting

the public, the exposures of those particulates from the various fires embed themselves into their skin and clothing.

The AQI again is a measurement, and that in itself creates knowledge as to the serious exposures, and risk factors to safety officers.

California has created a disputable legal presumption for certain medical conditions, and one of those conditions is pneumonia. Pursuant to the Labor Code a member of a Police Department, Fire Department, City Municipality, Highway Patrol, Sheriff, District Attorney and other individuals that develop pneumonia or manifest itself during a period of in which the member is in the service of the various

departments the conditioned could be presumed to arise out of and in the course of employment if developed properly.

The importance for the individuals that have these exposures is documentation and discussions of same if they seek medical care with the doctors. Also, share the various exposures and any manifestations of symptoms that they have post exposure.

Pneumonia is an infection of the air sacks in one, or both lungs. The air sacks can fill with a fluid or puss causing coughing, chills, fever, chest pains, difficulty breathing and possible change in mental awareness called phlegmatic. These are just some of the symptoms that may involve having pneumonia. Documentation with the doctor and the staff are paramount. Often times there is also fatigue, fever, sweating and for some people a shortness of breath, nausea, vomiting and diarrhea. This documentation can reflect the changes that have occurred with manifestation and development of pneumonia.

The changes that occur because of the various seasons, such as hot weather and fire weather, are also factors as to the impact to the pollutants that safety members are exposed to. The documentation and proper medical care affords a more reasonable likelihood of recovery. In the event the recovery is delayed for a period of time, this could give access to benefits pursuant to Labor Code §4800.5, §4850 and/or industrial leave depending upon the agency you work for.

The immediacy of the problem and the alleged recovery after you have returned back to work does not mean that there is not a change in function or residual impairment. If there is residual impairment after returning back to work, documentation of this is necessary because there can be recurrence, and you have five years from the date of injury to obtain a more adequate level of determination as to residual impairment, if there is any.

One of the most significant factors is obtaining medical care to cure or relieve the effects of the injury, this is obtained by showing it is work-related. A back-up is that if the condition arises to the point that you cannot do your substantial duties, you may be in an avenue of establishing more benefits



pursuant to Labor Code §4800.5, §4850 or potentially an industrial disability retirement.

The cases are developed with the idea that the worker will recover and be able to return back to work. Also if properly developed that they are entitled to have medical care to cure or relieve the effects of the injury. This award for lifetime medical care is not limited, but a lifetime award for the job related injury.

Again, your knowledge as to exposures and harm that can be caused is protective knowledge, and will allow you to move forward and have some umbrella of protection. The change in seasons that we are going to have, the additional exposures to wild land fires and other fires, as well as going to the range to fire weapons are all elements of substantial exposures that can be contributory to the pulmonary problems.

The pulmonary problems unfortunately can be a sign of another medical problem that may develop such as a heart problem. If that develops or elevated blood pressure develops, it is important that you give consideration to all of your work factors and the contribution of same. ★

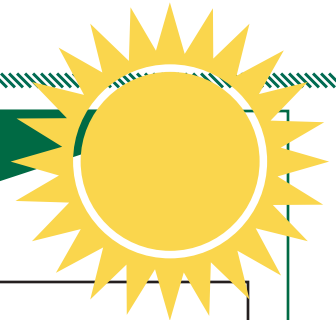

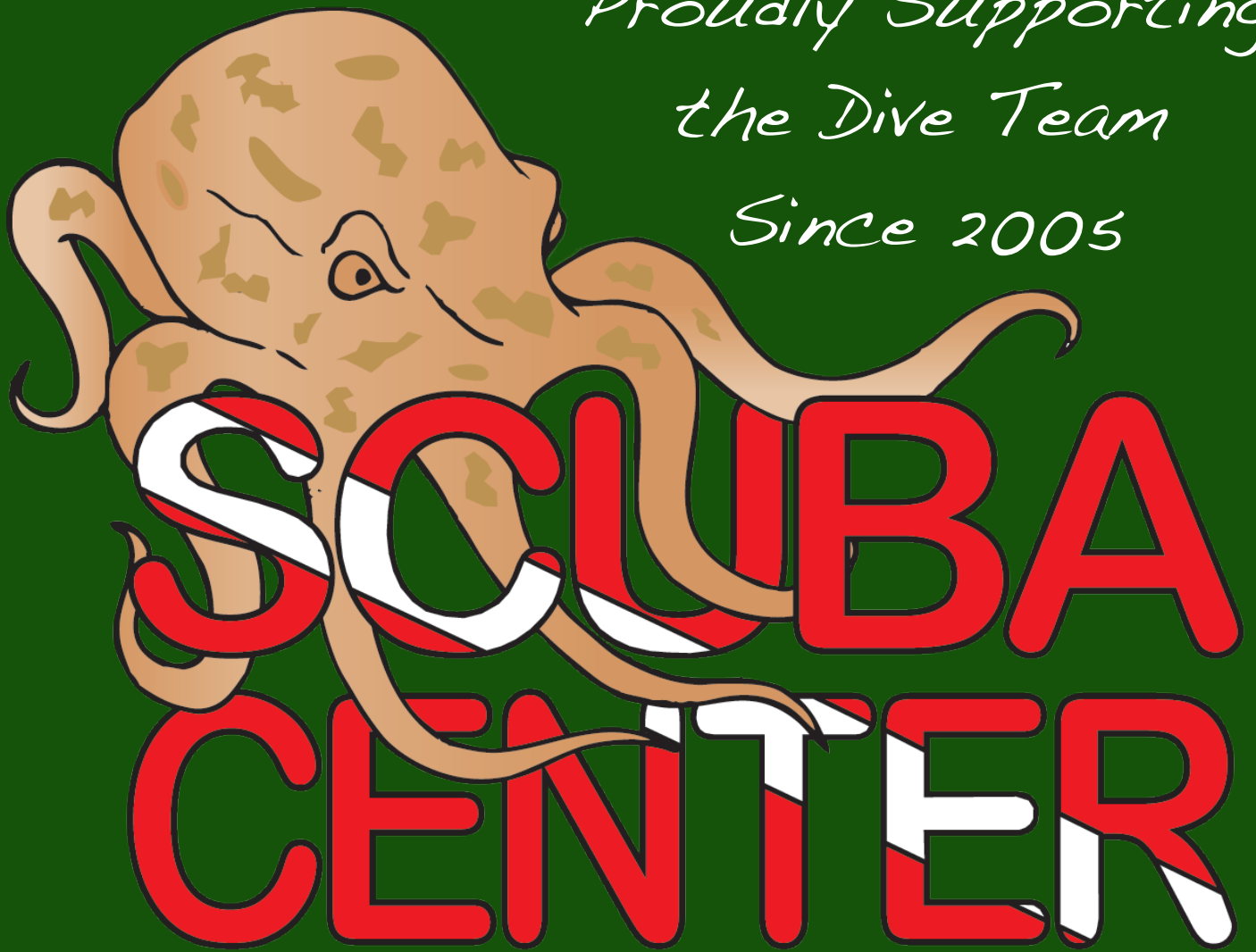

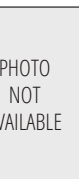
