"I have been refused the right to have a representative of my choice. I understand that I am being ordered to make a report or answer questions and that, if I do not comply with the order, I may be disciplined for insubordination.

Therefore, I have no alternative but to abide by the order. However, by so doing, I do not waive my constitutional rights to remain silent under the 5th and 14th amendments to the United States Constitution and under the protections afforded me under state law."

# An Historic Anniversary

## One year after a ground breaking election, morale is up and positive changes are transforming our department

**A**s we enter November, we get ready for Thanksgiving and prepare for the holiday season. November also marks the one-year anniversary of a historical election for our Association and Department. One year ago, this month, the Members of RSA were able to celebrate their unification in the election of a new Sheriff to represent the Riverside County Sheriff's Department. During the course of the election cycle, the Members came together, posted signs, and spread the word they wanted a new leader to represent the Riverside County Sheriff's Department.

On November 6, 2018, the Riverside County residents voted Chad Bianco the 14th Sheriff of Riverside County, showing they heard our Members and other supporters loud and clear. Watching the course of the election made me proud to see our Members come together and show enough was enough.

Sheriff Bianco took over the Department just under a year ago, and immediately started improving the morale of our Department while making positive changes. As a result of the Department morale increasing and the positive changes being made, our

decreasing numbers slowed and for the first time in several years we started to actually grow our Department.

Part of the changes made, was the change in the style of negotiating between the County Team and your RSA Teams. It's been a very long process for everyone, and I do apologize, but I ensure you we've been working consistently with all of the decision makers and I appreciate everyone's patience. I believe we are getting very close to having something very positive that both sides can agree on, and then get it put it out to our Membership for a vote. Both sides of the table have reviewed the terms other agencies surrounding us have obtained and have kept them in mind while negotiating. With this good news, I do remind you, however, that nothing is final until the ink is dry.

As for the PSU negotiations, both sides continue to meet and trade offers in an effort to find common ground to work from. Future dates are scheduled and your negotiating team will continue to fight for a fair and reasonable contract. Keeping up with Probation news, RSA received several calls from our PSU Members asking whom we were going to support for Chief of Riverside County Probation. Due to the large interest in the subject, RSA decided to conduct a survey asking the PSU Membership two basic questions:

1. Are you happy with the current Probation Executive Staff and the Interim Probation Chief?
2. Regardless, would you prefer that the new Probation Chief be

ultimately selected from outside the Probation Department?

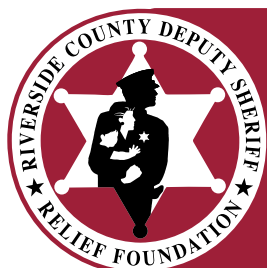
Prior to conducting the survey, I reached out to the Interim Probation Chief and explained what we'd be doing and why we were doing it (reference the survey) i.e. - in-order to get an accurate pulse from our Membership. During the month of October, the survey went live for just under two weeks, October 10 through the 22. The survey went out via email and was sent to the 452 registered emails we have on file. Of the 452 emails sent out, 247 Members (54.6%) logged into the secure website and submitted a "Yes" or "No" answer to the questions. The results of the survey were as follows:

1. Are you happy with the current Probation Executive Staff and the Interim Probation Chief? *Vote Totals: 204 No votes and 43 Yes votes*
2. Regardless, would you prefer that the new Probation Chief be ultimately selected from outside the Probation Department? *Vote Totals: 203 Yes votes and 44 No votes*

What I get from the survey is that 82% of the responding Members are looking for change and would like to see the next Probation Chief selected from outside County Probation.

Lastly, with the holidays approaching, please keep the Deputy Sheriff Relief Foundation in your thoughts and plans as it counts on donations from our members to help support our partners in their time of need.

As always, stay safe out there and help ensure your partners go home safe. ★

# 25th-Annual Riverside County Sheriff's Picnic

*Thousands gather at the 25th-annual Riverside County Sheriff's Picnic for loads of fun, food and camaraderie at now 'must-do' event*

**T**housands of Riverside County Sheriff's Department deputies, family members, and friends came out to the 25th annual Sheriff's Picnic on Saturday, Oct. 12, in a celebration of law enforcement camaraderie, exploration, music, food, and fun.

The picnic, a private event that took over the Diamond Valley Lake Valley-Wide Recreation Center in Hemet, included a live music stage; tournaments for softball, volleyball and, new this year, cornhole; and a children's zone with laser tag, rock climbing, a rideable train, bounce houses, and midway games. Various sheriff's department units set up booths to show off their equipment, methodologies, and personnel. Alongside them were various vendors selling wares.

Sheriff Chad Bianco, who's been in office since January, noted in a letter sent to attendees that the annual picnic was not always the "must-do" October event. But this year, he sought to change that reputation and make it a favorite reunion of colleagues old and new within a fun environment.

Bianco told the crowd before the afternoon concert featuring Jerrod Niemann that the picnic was about celebrating Riverside County's deputy family.

"It never gets old when people tell me from the public how happy they are with you and how you treat them," Bianco said. "That's what it's all about. I'm very humbled and proud to be your sheriff."

Among the picnic highlights were hands-on demonstrations and deputies eager to explain their trades from various department groups, including the dive, aviation, coroner, and hazardous device teams.

Angela Mendoza, a deputy coroner II and five-year department veteran, was eager to explain her job to the public. As a death investigator, she receives reports from various agencies, talks with the community and gets exposed to various locales, whether on a mountain or in a river.

"Wherever that body is, that's where we're going," Mendoza said.

Still, she added, with the coroner's booth this year they tried to bring in some kid-friendly fun: a black coffin labeled "bone dig" with candy hidden inside.

"I'm trying to bring them in because this booth, no pun intended, needs a little bit of life. You know what I'm saying?" Mendoza said with a laugh.

Deputy Devin Schmitt, an 11-year department veteran and member of the underwater search and recovery team from the Hemet station, was wading in a small pool set up at the park. Participants, mostly children, swam around the pool using department scuba gear.

The underwater breathing activity "brings perspective and comprehension to the public" about what the dive team does, which includes collecting evidence and looking for loved ones, Schmitt said. "People get an understanding that things happen underwater."

Deputy Kevin Schroeder, an 11-year veteran who just started with the hazardous device team, joked that his squad has "cooler toys than SWAT."

Their gear works to handle explosives and other dangerous items, getting them out of harm's way.

While standing inside the team response van, which has video equipment installed and other tactical gear, Schroeder said people sometimes see them as "just cops."

But events like the Sheriff's Picnic show everyone, including sheriff's deputy families, "what the entire department does, and what our capabilities are," he added.

Lily Rubio, wife of Deputy Marc Rubio, who works in the Robert Presley Detention Center, attended the picnic



with their two children, Evan, 7, and Scarlett, 2.

Evan particularly enjoyed seeing the equipment his dad's colleagues use every day.

"It's so interesting!" Lily said. "I love it."

Riverside Sheriffs' Association Executive Director Michael Abel said it was "so

great to see that many people out enjoying the day with their family and friends."

Added RSA President Bill Young: "I would like to thank all the RSA staff and department volunteers that worked hard making sure this event was a huge success. This was one of the largest turnouts at a department-sponsored event, and I can't wait to do it again next year." ★



# Class 86 Graduates

**Class 86 of the Riverside County Sheriff's Department Basic Correctional Training Academy: 'Together as one, defeated by none'**

**T**he 23 graduates from Class 86 of the Riverside County Sheriff's Department Basic Correctional Training Academy logged 374 hours over eight weeks, immersing themselves in a demanding, and sometimes excruciating, regime that pushed recruits to the limit — both physically and mentally.

In order to graduate, every academy recruit was required to score at least 80 percent in all practical, physical and written tests. With family members and RCSD officials looking on, each member of Class 86 was celebrated for their accomplishments during a graduation ceremony Oct. 10 at the Grove Community Church in Riverside.

"You are here today because you stayed that course and completed your goals," said RCSD Correctional Sgt. and academy coordinator Chuck Lemons. "You are part of a team, better yet a family, which represents more than you as individuals. What you do from here sets the tone for your future as members in society and leaders in our community."

Three of the graduates will go to work for the Pomona Police Department. The rest will begin their law enforcement careers supervising inmates in one of the largest jail operations in the nation.

"We have established a new foundation of discipline, integrity, loyalty, professionalism and leadership," said graduate Cecil Garcia, president of Class 86. "No matter what we may go

through in our careers, we now have 23 brothers and sisters to turn to for support and guidance.”

Garcia was among several graduates who were given awards for excelling in specific areas of training. The 25-year-old former ice hockey player received an award for being No. 1 in physical fitness and was named the most inspirational recruit in Class 86.

RCSD recruit Adam Drexler earned top academic and top report writing honors. Recruit Erika Rogero earned the James B. Evans Award for academics, and Vin Vuong was named top overall recruit.

“On day one, we were just 34 individuals with our heads missing wondering where to line up and how to get in formation,” Garcia said. “Now we come to you as a family of 23 brothers and sisters.”

Delivering the keynote address was RCSD Chief Deputy Don Sharp, who not only served as an inspiration to the class, but was inspired himself by the grit displayed by Class 86, whose class motto was “Together as one, defeated by none.”

A 30-year member of law enforcement, Sharp acknowledged being a bit out of shape. He decided to get back in shape by performing physical exercise alongside the recruits who were decades younger. That included challenging the academy class to race 1,330 feet up Mt. Rubidoux.

Sharp stressed the importance of faith, family, friends, and fitness as being

an integral part of a successful career in law enforcement.

The chief deputy also praised Class 86 for exhibiting teamwork.

“The way you worked together and helped each other achieve your goal is something you should never forget and be proud of,” he said. “Your desire to succeed was inspirational.”

Sharp also urged the graduates to behave with dignity and to show respect, even toward the inmates they will be supervising.

“That can be difficult at times knowing the offenses they have committed against others, but we are professionals,” Sharp said. “Disrespecting people does

not mean compliance. It only diminishes your authority.

“Remember, service above self applies to all citizens — even those we supervise in our jails. You are all ethical men and women with great integrity. Please don’t let me ever hear that it changed.”

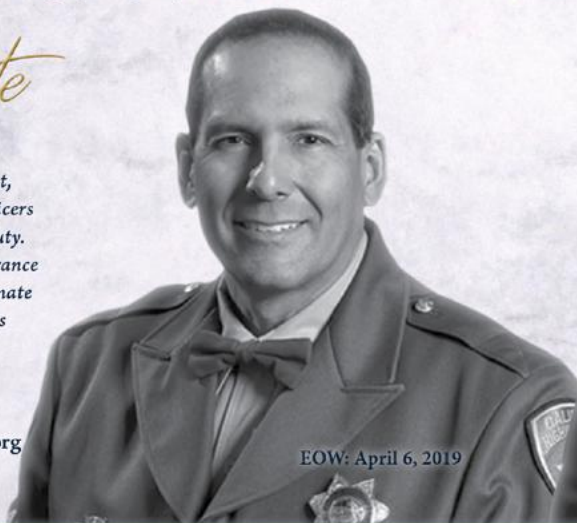

This first chart shows how the legislators voted on controversial bills of interest to the RSA that made it all the way through to the legislature. These bills are all authored by Democrats who hold a supermajority (more than 2/3) in each house. Controversial bills authored by Republicans rarely earn passage in both houses. The total number of votes and the corresponding percentages should not be viewed as the only measurement of an individual legislator's support or opposition of law enforcement officers or public safety. Keep in mind, some of the most harmful bills failed to pass in their first committee hearings. Likewise, many of the best public safety improvement bills never made it out of committee. Asterisks\* denote bills that were vetoed by Governor Gavin Newsom. Votes in red are votes cast in opposition to the RSA's position. NOT VOTING (NV) is indicated when the legislator is present but chooses to not cast a vote either way. NV is the same as a NO vote. If the RSA is requesting a NO vote on a bill, NV is just as good. Similarly, if RSA is requesting a YES vote, a legislator who abstains and is recorded as NV, is credited with a NO vote.

- AB 32 Bans private prisons and other detention facilities in CA.
- AB 45 Eliminates \$3 county inmate co-pay for medical visits
- AB 314 Requires public employers to allow employee time off for union duties\*
- AB 965 Reduces punishment for young, violent, adult inmates
- AB 1215 Bans law enforcement from using body cam footage with facial recognition technology
- AB 1282 Bans private prison transport companies from state facilities\*
- SB 136 Reduces sentences for habitual, repeat, violent offenders
- SB 266 Reduces financial penalty for CalPERS members inadvertently provided disallowed compensation
- SB 310 Allows repeat, habitual, violent felons to serve on criminal and civil juries
- SB 394 Creates giant loophole allowing violent offenders to avoid another criminal conviction
- SB 316 Domestic violence hotline number to be included on student identification cards
- SB 416 Extends current peace officer workers comp presumptions to more peace officers
- SB 542 Establishes a PTSD workers comp presumption for peace officers and firefighters
- SB 622 Requires private detention facilities to report all deaths to CA Attorney General\*

### AB 392 - USE OF FORCE

Some bills such as AB 392 were significantly amended prior to a final floor vote, which allowed the RSA to remove its opposition and inform the legislators that we were no longer opposed to the bill. However, three Riverside-area legislators supported the earlier versions of 392 that would have placed officers and the public in increased danger or facing criminal prosecution when force was used.

Assembly member Jose Medina co-authored the original version of AB 392. Medina also participated in press conferences and rallies where he accused law enforcement officers of targeting minorities with excessive and deadly force.

Assembly member Eduardo Garcia also committed to support

the earlier version of the bill, although he was not present in Sacramento when amendments were adopted and voted on by the entire Assembly.

Senator Richard Roth actually voted in favor of 392 before the amendments were included in the bill. While he claimed he did want the version he supported to become law, he did want the bill to move out of the Senate so it could be properly amended in the Assembly to address law enforcement's concerns.

AB 392 is therefore not included in our scorecard because it does not accurately reflect the various versions of the bill and that the final vote in each house did not accurately reflect the positions taken by legislators while RSA remained opposed. Those in the "SUPPORT RSA" column either voted against the earlier versions of 392 or refused to support the earlier versions. Similarly, those in the "OPPOSE RSA" column either voted for an earlier version of 392 or had committed to supporting the earlier versions.

**TWO YEAR BILLS**

Other RSA tracked bills were stopped in the legislative process prior to a full vote of each house. As a result, those bills were removed from our scorecard as we await further action on them in 2020. This group of bills is called "2-year bills" because they failed to pass both houses of the legislature before the

deadline last September. Some or all of these bills may be voted on by the legislature in January 2020 when the legislators return. We will examine these 2 year bills in next month's publication as we prepare for the return of the legislators in January. Until then, be safe. ★

# Deputy Pilot Protects From On High

And Also Gives Back To Law Enforcement By Heading Up Relief, Donation Efforts

**H**overing over the San Jacinto Mountains, seemingly able to see forever in any direction, Riverside County Sheriff's Deputy Chad Marlatt has to remind himself every day that he's actually working.

Trust us, he is.

In addition to being a pilot on the Riverside County Sheriff's Department's (RCSD) Aviation Unit, Marlatt is on the Board of Directors for the Riverside Sheriff's Association, he is president of the Riverside County Deputy Sheriff Relief Foundation, and he is chair of the Riverside Sheriffs' Association Special Events & Donation Committee. Marlatt also is vice chair of the Benefits Trust.

"It's not about me," Marlatt says. "It's about helping our brothers and sisters in the association and law enforcement in general."

As a pilot in the Riverside County Sheriff's Department's (RCSD) Aviation Unit, a typical day for Marlatt might involve swooping down into the wilderness to rescue an injured hiker in the morning and chasing down a robbery suspect racing down the 15 Freeway in the afternoon.

With Marlatt piloting the ship and his tactical flight officer beside him, the two-person crew can establish perimeters, clear areas, and guide units on the ground to where they need to be.

"Anything we think we can be an asset from the air, that is what we are there to

do," said Marlatt, one of 11 deputies on the unit and the one with the most time in the air.

In March, Marlatt amassed 6,000 hours of flight time, reaching the milestone accident free.

"If I'm in the TFO (tactical flight officer) position, he's probably the pilot I would want flying if it was the most technical type of flying we have to do," said Dep. Ray Hiers, one of the newer members of the unit. "If you get into a high-stress situation, you want to be flying with something who you don't have to worry about what they're doing and just focus on what you are doing."

The Aviation Unit's primary function is patrol, but search and rescue operations are a close second.

The unit performs up to 300 search and rescues annually, said Marlatt, who started with the unit 15 years ago as

a tactical flight officer and has been a pilot since 2009.

Back then, the crew used Thomas Brothers Guide maps to navigate, Marlatt said.

Today, RCSD ships are equipped with thermal imaging cameras, high-intensity searchlights, and downlink equipment enabling video to be sent to the ground.

RCSD air crews patrol over urban areas such as Corona and over the Mt. San Jacinto Wilderness, where the highest peak is above 10,800 feet.

On a recent Sunday, the unit rescued an injured hiker on Box Springs Mountain above Moreno Valley.

STAR 9 picked up the hiker and flew him to Riverside County Fire personnel waiting at a nearby school.

Earlier in October, the unit rescued two hikers who'd gotten lost in Idyllwild.

## FORMER EXPLORER

Marlatt was drawn to a career in law enforcement by his stepfather who was a Riverside County Sheriff's deputy.

After beginning his career with the Riverside County Sheriff's Department as an Explorer, Marlatt became a Sheriff's Service Officer in 1996.

He was a deputy in corrections for six months and then moved to patrol.

When on a ride-along with the Aviation Unit in 1998, Marlatt discovered his calling.

"One day, that's what I want to do," Marlatt said to himself. "Just the feeling of going up in the air and what you can see, versus being on the ground. It's almost euphoric."

Two calls stand out from his early days in the air.

One was in 2008, when Marlatt and his pilot chased bank robbery suspects all the way down to Escondido.

Marlatt watched from above as the suspect's car flipped over, the suspect was ejected, and bills flew out everywhere.

Another call involved two suspects who had followed a man home from a casino to rob him.

A deputy on the ground attempted to pull the car over, but the suspects fled and the pursuit was on.

Marlatt's unit gave chase from overhead as the suspects sped along the 215 Freeway towards Perris.

The vehicle stopped and the passenger surrendered, but the driver got into another car and took off.

The suspect shot his way into a house, grabbed a set of car keys, and took off in a car parked in the driveway.

Two deputies on the ground were wounded trying to stop the suspect, who also shot at Marlatt's helicopter.

Sheriff Relief Foundation, chair of the Riverside Sheriffs' Association Special Events & Donation Committee, and vice chair of the Benefits Trust.

Those needs may stem from medical emergencies, funeral expenses, and memorial travel expenses.

After RCSD Dep. Jason McMillan was severely wounded during the mass



"That was definitely a hair-raising experience," he said. "You hear the clunk. You turn off the lights, check all the gauges."

But Marlatt isn't only serving the public.

He handles many needs in his roles as president of the Riverside County Deputy

shooting at the Route 91 Harvest Festival in Las Vegas on Oct. 1, 2017, the foundation paid the expenses for McMillan's family to travel to Las Vegas.

McMillan was shot while trying to shield his girlfriend from the gunfire raining down from the 32nd floor off the Mandalay Bay Hotel. He sustained liver and lung wounds and has a bullet in his spine. The foundation contributed \$8,000 toward the purchase of a special SUV suited for his needs.

When Dep. Jay Youngblood was left paralyzed below the waist after a motorcycle training accident in July 2018, the foundation covered travel and lodging expenses for his family while he was in the hospital.

With the support of Sheriff Chad Bianco, the RCSD soon will open a new hangar in Palm Desert and up the staff from 11 to 16 deputies.

"I'm fortunate to be here," Marlatt said. "We're a public service. That is what I'm here to do ... save lives." ★
