SUMMARY ANNUAL REPORT

FOR RIVERSIDE SHERIFF'S ASSOCIATION LEGAL DEFENSE TRUST

This is a summary of the annual report of the Riverside Sheriff's Association Legal Defense Trust, E.I.N. 33-6200313, Plan No. 501, for the year ended December 31, 2019. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$4,681,939 as of December 31, 2019, compared to \$4,195,391 as of January 1, 2019. During the plan year, the plan experienced an increase in its net assets of \$486,548. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$1,883,240 including employer contributions of \$1,380,874, realized gain of \$63,654 from the sale of assets and income from investments of \$438,712.

Plan expenses were \$1,396,692. These expenses included \$419,344 in administrative expenses and \$977,348 in benefits paid to or for participants and beneficiaries.

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
